6. SBA Guidance Disaster Funding

The U.S. Small Business Administration website is now showing **Pennsylvania and Tioga County, PA as eligible** for SBA disaster funding.

For both Pennsylvania and New York, when you open the (Disaster Loan Assistance Link Below) the Eligible Disaster Area (red) link will provide the confirmation that your County is eligible.

This enables small businesses to apply for **Economic Injury Disaster Loans**.

The loans can be used to:

- pay fixed debts,
- payroll,
- accounts payable
- and other bills that can't be paid because of the disaster's impact.

Interest rate: for small businesses is 3.75%. The interest rate for non-profits is 2.75%

Loan Forgiveness: A Federal Stimulus Package is under discussion that may include partial loan forgiveness if certain conditions are met by the business, but there are no guarantees at this time.

7. Families First Coronavirus Response Act. Aid to workers at small US companies:

The Senate passed and the President signed the Families First Coronavirus Response Act.

- Preliminary details:
- The Act applies to <u>employers with fewer than 500 employees</u> and would provide for <u>paid sick leave</u> and <u>expanded eligibility for FMLA leave</u> for workers affected by the virus under certain circumstances.
- The bill was narrowed significantly to ensure passage in the Senate.
- Employers are to be reimbursed for paid leave with tax credits.
- The Act specifies and caps pay rates for each kind of leave and specifies eligibility.
- Certain exceptions apply.

There's no question that the implications of Covid-19 have already been very disruptive and the next several weeks will be prove challenging for our valued customers and essentially all industries. Keck's Food Service will continue to monitor Covid-19 developments closely and will work diligently to support your business and minimize service and supply disruptions for your operation.
